February, 3, 2021 COSGPAA Chapter Update

The February 3rd Chapter meeting was cancelled due to the health restrictions imposed within El Paso County to prevent the spread of the COVID virus. Current restrictions limit our meeting capacity to 25% and require 12' social distancing for indoor meetings. That would be only 12 people. With the number of infections decreasing and vaccinations increasing, we expect we will move into a less restrictive environment (Condition Yellow) by the end of the month. While we will still require face masks, even for those vaccinated, the separation distance drops to 6 foot and increases our allowed attendance to 25. As of this writing, the Gold Prospectors of Colorado (GPOC) meeting on Wednesday, Feb 10th is still on. If you are planning to attend, remember they have moved to the American Legion in Fountain.
